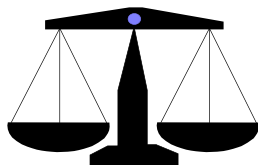


## What Is Mental Health Crisis Court?



The Mental Health Crisis Court is a division of the Delaware County Court of Common Pleas responsible for administering Pennsylvania's involuntary commitment laws for persons with mental illness. Patients may retain private legal counsel if they wish. For those who do not retain private legal counsel, a court appointed attorney will be present. Individuals under the age of 18 years should be accompanied by a family member or guardian.

## Where is the Mental Health Crisis Court?

The Mental Health Crisis Court is held at Crozer Chester Medical Center - North Campus, 301 W 15th Street, Upland, PA 19013. Enter through the front door of the Wound Care Center. **Due to the ongoing pandemic, all court proceedings are being held virtually. Any questions/concerns, please call MH office at 610-713-2365**

## When is Crisis Court ?

Court is regularly held on Tuesday and Friday mornings beginning at 9:30 am.

In the event of a holiday, check with the inpatient social worker. .

## What happens at a Mental Health Crisis Hearing?

A 302 is a petition for an involuntary commitment of up to 120 hours. The 302 must be filed by the person who observed the behavior. If the hospital treatment team recommends further hospitalization beyond the 120 hours, a Mental Health 303 Hearing is scheduled. A patient has the right to agree or disagree with what the 302 petition says and with the treatment team's recommendation for further hospitalization. Testimony from both sides of the issue will be heard by the Court. If the Mental Health Review Officer determines the patient should be held for further treatment, a 303 Order is issued. This is a court order for extended treatment in a psychiatric setting for a period of no more that 20 days. It is suggested that the 302 petitioner attend, via telephone, to offer testimony for the court hearing.

**A 302 is a Petition for involuntary commitment of up to 120 hours. A 303 is a Court Order for extended treatment of no more than 20 days.**

## What to expect on the day of Crisis Court

Prior to the Crisis Court Hearing each patient will be given the opportunity to speak with the appointed patient attorney. The patient's Psychiatrist reviews all relevant information prior to the court hearing. Family members or friends may be available for this examination, if the patient desires. The 302 petitioner is encouraged to be available for the court hearing, via telephone, to offer the testimony written on the 302 petition. .

After being examined by the psychiatrist, the patient has the opportunity to speak with the court-appointed patient attorney.

When a patient agrees to receive further treatment the patient is escorted into the courtroom to enter his/her agreement for continued treatment on the record before a hearing officer.

When a patient requests a hearing, the patient is escorted into the courtroom to tell the Court why he/she does not think that further treatment is required before a hearing officer. The hearing officer will render a decision that is in the best interest of the patient after listening to testimony from all parties. Family members/friends may accompany the patient at this time.

## DIRECTIONS

### From Center City Philadelphia

Time: 20 minutes

1. Take I-95 S.
2. Exit 6 Crozer-Chester/Widener University
3. Make right off exit ramp to 1st left, E. 13th Street
4. Make 1<sup>st</sup> right onto Walnut Street
5. Make 1<sup>st</sup> left onto 14<sup>th</sup> Street
6. Cross over Providence Road
7. Cross over Rte. 352, continuing straight for 3 blocks
8. At end of North Campus Building (on right) turn right onto W. 15<sup>th</sup> (On street parking is available)
9. Entrance at Wound Care Center

### From the Blue Route (I 476 S.)

Time: 15 minutes

1. Take I 476 S. to I-95 S.
2. Exit 6 Crozer-Chester/Widener University
3. Make right off exit ramp to 1st left, E. 13th Street
4. Make 1<sup>st</sup> right onto Walnut Street
5. Make 1<sup>st</sup> left onto 14<sup>th</sup> Street
6. Cross over Providence Road
7. Continue from #7 above.

### From Delaware State Line

Time: 8 minutes

1. After exit for Rte 322 E., move to extreme right lane
2. Exit at Kerlin Street; then turn left onto Kerlin Street
3. When Kerlin Street ends, turn right onto Upland Avenue
4. Pass Sunnyside, Garden and Presidents Drives
5. Bear left at North Campus Building (fork in road) onto W. 15<sup>th</sup> Street (On street parking is available)
6. Entrance at Wound Care Center

### From US Rt 1 & Rt 352, Media

Time: 15 minutes

1. Take Route 352 S.
2. After the Brookhaven Shopping Center, road becomes two-lane Edgmont Avenue
3. After 1/2 mile, turn right onto 22nd Street
4. Bear left at the "V"
5. At stop sign, turn left onto Upland Avenue
6. Continue from #5 above.

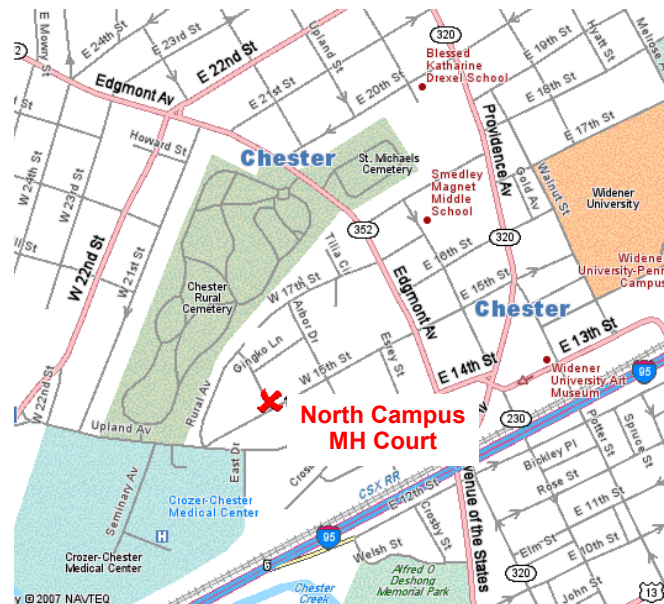

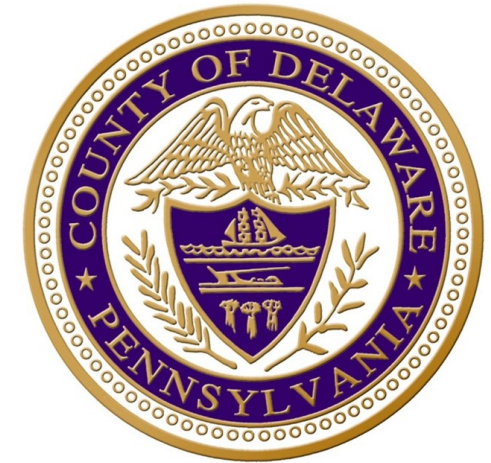
